Liam Donovan's Bottom Line

Bumpy Landing for BIF; Ongoing Turbulence for BBB. A tense day of vote wrangling and repeated false starts in Democratic bids to advance their stalled legislative agenda ended with muted progress this evening, as the House passed the bipartisan Infrastructure Investment and Jobs Act (BIF), along with a procedural rule necessary for eventual consideration of the reconciliation tax and spending package, but failed to move the Build Back Better Act (BBB) itself. The frenetic day capped off a rollercoaster week for Biden and the congressional Democrats, in which a promising progressive about-face on process and sequence was quickly eclipsed by frosty public comments on the framework by pivotal Senator Joe Manchin, overshadowed in turn by a brutal election night that saw Republicans sweep the constitutional offices in Virginia, nearly pick off a "safe" incumbent Governor in deep blue New Jersey, and make state and local gains in races across the country.

The election night fallout led to a strategic shift from Speaker Nancy Pelosi, who abandoned the months long strategy of close coordination that sought to "pre-conference" an agreed upon bill with the Senate, instead charging ahead with a plan designed simply to get reconciliation out of the House. In a bid to win the necessary 218 votes, the Speaker unilaterally added back the paid leave program while cutting deals on SALT relief, immigration considerations, and other smaller changes designed to persuade the remaining holdouts. Updated language was released mid-week, and the Rules Committee held lengthy sessions on Wednesday and Thursday before reporting a rule setting the terms of consideration for a retooled version.

The new tack is an acknowledgement of two things--first, that the "dual track" approach would be abandoned as the BIF would be delivered to the President's desk with no assurances on the Build Back Better Act (BBB); and second, that the House version of the bill would face considerable changes in the Senate, meaning they would have to vote again before the package could be signed into law.

While Democrats seem to be generally converging on substance and forging requisite compromise on tricky issues, an uncertain path lies ahead in the Senate, where Joe Manchin has signaled dissatisfaction with the bill, deriding its structure as "shell games" and "budget gimmicks," and rejecting the notion of the House BBB as a basis for the final text. Manchin's hostility toward the House product likely informed the reservations of a small rump of House moderates who pledged to withhold their support until the Congressional Budget Office (CBO) releases its official score, among other procedural demands. The group's refusal to back down in the lead-up to planned votes on both bills led Speaker Pelosi to offer an alternative arrangement, where the moderates would support the BBB rule as a good faith gesture and the House would pass the BIF. Progressives balked at this plan, threatening to vote it down if Pelosi put it on the floor. The White House interceded directly to help find a way for progressives to support the bill, which led to a late-night pledge from moderates, backed by the President's word, to back the House BBB if and when the CBO score comes back as expected. The agreement ended the tense standoff and opened the door to late night votes on the BIF and the rule, while the newly decoupled BBB remains in limbo.

Congress now departs Washington for a recess week, before returning for a week-long work period before the Thanksgiving holiday. Leadership hopes the official score for the Congressional Budget Office will be available that week, satisfying the demands of moderate holdouts, and the Senate to begin its role in the reconciliation process. The score may also inform the durability of the previously agreed upon language, and the need to revisit the pay-for section of the bill which has otherwise been largely firmed up.

Given the inevitable substantive changes, redrafting, parliamentary vetting, and Senatorial novelties such as the vote-a-rama, consideration will almost certainly slip into December, where it stands to converge with the government funding and debt ceiling deadlines. Final passage will depend in a large part on Manchin's sense of urgency, and the House's appetite to swallow whatever the Senate is able to send back.
